The remaining sources of supply were the Pouce Coupe and South Pouce Coupe fields situated in Alberta, over which the Department has no control."

His Honour was taken ill last Friday in Vernon, where he was about to carry out another of those many official duties which he has always performed so willingly and so graciously. However, we are heartened by the latest report, that he has passed a comfortable night in the hospital at Vernon. We offer to him and to Mrs. Pearkes the warmest wishes of this House for his speedy and complete recovery."

"That the members of this Legislative Assembly offer to His Honour the Lieutenant-Governor George R. Pearkes and to Mrs. Pearkes their warmest wishes for his speedy and complete recovery."

Mr. Speaker made the following statement:-

Honourable Members,—On Thursday afternoon last at the opening of the sitting, a point of order was raised by the honourable member for Oak Bay, whereby a ruling was requested on whether or not Select Standing Committees may, at their organizational meeting, by reference to the House, request that certain matters and things be referred to them for consideration and report.

Standing Committees are those Sessional Committees which are appointed beforehand for the consideration of all subjects of a particular class arising in the course of a Session. The tendency of modern practice is to refer to Committees all matters requiring the taking of evidence and laborious investigation. In this way the House is able to simplify its proceedings and make greater progress with the public business. (Bourinot, 4th edition, pages 454, 455.)

Select Standing Committees of the House are appointed by motion at the commencement of each Session in accordance with Standing Order No. 68, and such Committees are empowered by that motion "to examine and inquire into all such matters and things as shall be referred to them by this House . . ."

May, 17th edition, at page 643, states that "Select Committees are regarded as portions of the House, limited in their inquiries by the extent of the authority given them . . ." and Bourinot at page 464 expresses an identical Rule.

Mr. Speaker Carson deals partially with the subject at page 147 of the 1948 Journals of this House, and he determined "No matter or thing having been referred to the Committee by this House, it necessarily follows that this House may not receive a report from said Committee."

Further, May, 17th edition, at page 641, states that "A Select Committee, like a Committee of the whole House, possesses no authority except that which it derives by delegation from the House by which it was appointed. When a Select Committee is appointed to consider or inquire into a matter, the scope of its deliberations or

inquiries is defined by the order by which the Committee is appointed (termed the order of reference), and the deliberations or inquiries of the Committee must be confined within the limits of the order of reference."

It is axiomatic therefore, and a clear principle of parliamentary law, that in the absence of an order of reference which would lay specific matters or things before a Committee, Select Standing Committees are powerless to act, and can neither initiate, recommend, nor otherwise request that the House refer a matter to them for consideration and report.

Honourable members who desire that specific matters be referred by the House to a Select Standing Committee have procedures available to them in the House to seek such a referral. However, the procedure initiated within the Select Standing Committee on Municipal Matters by the honourable member for Oak Bay was not in order, and I so rule.

- "(a) Some surveys have been made on the probable effect of the Portage Mountain Dam, and subsequent lake, on fish and wildlife. Detailed studies have not been made and would prove costly, and the benefits from these are open to question in terms of corrective action that could be undertaken at this time. The main effects will involve the loss of big-game winter range and waterfowl habitat. It is anticipated that a worth-while fishery for such species as Dolly Varden, rainbow trout, whitefish, and kokanee could develop. This will depend, however, on the extent to which a partially cleared reservoir will physically permit both commercial and sport fishing.
- "(b) Studies have been conducted in respect to the Mica, Arrow, and Duncan dams and reports have been prepared. Resulting from the Duncan River study, a large-scale project is currently under way on the Lardeau River to compensate for the loss of kokanee spawning-grounds on the Duncan River. This involves construction of an artificial spawning-channel. Total project costs about three-quarters of a million dollars. In respect to wildlife, there will be a loss of habitat mainly for game animals and waterfowl. It is hoped that the effects of the Duncan Dam can be offset by increasing attention to the development of the Duck Lake area, which is now covered by a 11,000-acre reserve for wildlife-management purposes. The present hydro projects will not likely affect big-game hunting in British Columbia to a measurable degree. This may not be the case, however, if many additional projects are carried out without adequate provisions for the mitigation of wildlife losses."

courses there are waiting lists. Advisory committees normally determine intake in line with job vacancies in order that over-training in one area does not result in trained personnel being unemployed."

- 1. What is the planned opening date for the vocational school at Dawson Creek?
 - 2. What is the estimated enrolment of students for opening of classes?
 - 3. What subjects will be taught at the school?

"1. The planned opening date for the vocational school at Dawson Creek is September 6, 1966, for some programmes. It is hoped that all programmes will be available to the public by November 1, 1966; however, this will be dependent on the progress of the contractors.

"2. The estimated enrolment by November 1, 1966, is 360 day students plus additional students in up-grading courses at night as is needed by the community.

The subjects to be taught initially at the school are: Agriculture (farm management, marketing, soils and fertilizers, herbicides, etc.); automotive repair; basic training for skill development (vocational preparation in maths., science, and communicative skills of English); building construction, millwork, and joinery; cooks and chefs training; general commercial and business machines; heavy-duty and farm machinery mechanics; secretarial practice; and welding (general and specialized)."
